## **MEMBERSHIP APPLICATION - WRITER**

#### ADMISSION CRITERIA AND NOTES FOR MEMBERSHIP

Please read the following information before completing your application: -

#### 1. Eligibility and Qualifying Criteria

Any writer or co-writer of at least **ONE** musical work that has/have been either

- a) commercially published, or
- b) commercially recorded, or
- c) broadcasted, or
- d) performed in public or on platforms such number of times as the council shall in its absolute discretion consider appropriate having regard to the nature of the work and the performance or performances in question.

#### Definition

- a) Commercially published means: Made available to the public by sale or hire in graphic form
- b) Commercially recorded means:
  - i) the work has been released to the public over various platforms including record label listed in Musicmaster, Gramophone catalogues or
  - ii) the work has been recorded and made available by inclusion in a catalogue of a recorded music (e.g. background or mood music) library, or
  - iii) the work has been recorded and transmitted by a television or radio broadcasting station or cable diffusion service, or
  - iv) the work has been recorded on the soundtrack of a film or other audio-visual production that has been released for public exploitation.
- c) Publicly performed means: Performed in premises that are or are eligible to be licensed by the Society.

#### 2. Assignment of Rights

Upon admission to COMPASS as a member, the following rights are assigned to COMPASS for administration: -

#### • Performing Rights

The rights assigned to the Society by this Deed in relation to a musical work:

- a) to perform the work in public;
- b) to communicate to the public
  - "Communicate" is defined as "to transmit by electronic means (whether over a path or combination of paths or otherwise) a work or other subject matter, whether or not it is sent in response to a request and includes:
  - (i) Broadcasting
  - (ii) Inclusion in a cable programme
  - (iii) The making available of the work in such a way that the work or subject matter may be accessed by any person from a place and at a time chosen by him.

The assignment of Performing Rights is <u>compulsory</u>.

#### • Reproduction Rights

The expression "reproduction rights" shall mean, in relation to a musical work:

- a) the right to make a record of the work, in the form of a disc, tape or any other form whatever, and to make copies of such records for retail sale (the "mechanical right");
- b) the right to record the work onto the sound track of a cinematograph film including films intended for exhibition in cinemas or for transmission by broadcasting or diffusion services, or of other audio-visual productions (the "synchronisation right"); and
- c) the right to record the work as a commercial jingle or an accompaniment to commercial (the "advertising right").

The assignment of Reproduction Rights is <u>optional</u> to the member. However, administration of this right is only available to COMPASS members.

#### 2. Assignment of Rights (cont'd)

#### • Usage of own works

Members may continue to use their own works (100% share) and may request the Society to waive the collection of tariffs for the use of these works in specific instances, such as for charity use, self-organised concerts or specially commissioned works, subject to prior notice in writing of not less than three (3) months before the intended use and provided the Society has not yet licensed such usage. The Society has decades of established track record in fighting for members' rights in licensing concerts, digital services, etc.; liaising with international societies for documentation and foreign income; and showing sustained royalty revenue growth. By the Society administering your rights exclusively, members can best enjoy the efficiency and ensure their rights are legally protected. Members who choose to deal directly with music users should recognize that the Society will no longer be able to collect royalties or enforce any legal protection for your rights and should seek independent legal advice before varying their membership.

#### 3. Types of Membership

#### • Associate Member

- All newly approved members will be admitted as Associate Members and will remain so for a minimum of three (3) years.
- The review of membership status from Associate Member to Full Member will occur annually, three years after members have joined the Society.
- ♦ Will receive / have access to a copy of the approved Annual Reports.

#### Full Member

- ♦ (Writer) Members must meet the following criteria:
  - (i) are Singapore Citizens or Permanent Residents residing in Singapore;
  - (ii) have joined the Society for no less than three (3) years;
  - (iii) whose royalties collected through the Society fulfil the minimum criteria set by the Council from time to time, currently being a total royalty earning of \$\$50.00 nett for the past two (2) years, collected through the Society; and
- Will receive/ have access to a copy of the Meeting Notes and approved Annual Reports.
- Allowed to attend and has the right to vote at the General Meeting.
- Allowed to be nominated for election as a Council Member.

#### 4. Obligation of Members

### Notification of Works

All past, present and future works of a member are to be registered with COMPASS to enable the society to have a comprehensive/complete listing of the works that it administers on behalf of its members, and to ensure accurate allocation of royalties to the members.

#### Update of Particulars

Members should notify the Society immediately of change of address, email address, bank account number or contact numbers. Any royalty unable to be remitted after two (2) years due to obsolete member particulars will be void.

#### 5. Termination or Variation of Membership

Any Member may terminate or vary his membership by giving notice in writing to the Secretary along with the Member's contact information. Society will inform the member of the effective date of termination or variation, between six (6) to nine (9) months after receiving such notice.
